Geoff Henderson – Oral Re.: Gaps in services; female population's need for services; AB 109 report created by Los Angeles County; requested Partnership to consider having a Community based representative on Board.

Reginald Diamond – Oral Re.: Challenges of individuals once released from jail and the need of direction and programs to assist them.

Frank Flavin – Oral Re.: Overcrowding issues and funding shortage concerns. Chief Deputy Probation Officer Chris Bieber and Assistant Sheriff Mike James responded.

Joseph Kuykendahl – Oral Re.: New Start Program that assisted him when he was released from jail. Goal of Re-Entry Awareness Project (REAP) to bring community awareness of AB 109.
